The Company collects and processes personal data for user administration, the general implementation of the

The personal data collected by the Company will serve mainly to comply with the agreement relating to the provision of a service by the Company. If this data is not provided, the Company is unable to fulfil its contractual obligations.

Processing data and terms

The Company processes the following types personal data of the User:

- to create an account: User's name, address, postal code, city, email address, login details, IP address, information about the User's access and usage of the services, settings and preferences
- to subscribe to the services of the company: User's name, address, postal code, city, email address, login details, payment details, account name or profile name and information relating to the technical and hardware environment (eg. device information, operating system); • to send the User our newsletter: User's name and email address;
- to handle complaints and questions: User's name, telephone number, email address, account number, any
- information the User provides as content of User's message.

Personal data is never stored for a longer period than as strictly necessary and can be viewed, altered and

removed by the User at any time. Viewing, altering and removing (including the right to be permanently removed), and withdrawing the User's consent can be effected through a clear statement addressed to info.uk@veguro.com. If the User feels that the personal information of the User is used, gained, saved and/or obtained incorrectly, and User is unsatisfied with the outcome of the request to the Company, User can submit a complaint at the supervisory authority in User's country at any time.

The Company will remove the personal data of the User:

For the processing of payments the Company uses Payment Service Providers. Personal data, insofar as it is

required for processing the payments, will be collected by the Payment Service Providers itself. The privacy statement of that specific payment provider applies to the collection of personal data necessary to provide their services.

Data breaches

The Company handles User's personal data with utmost care and does everything reasonably possible to store

the personal data in a safe manner. If and to extent required, possible data breaches will be reported to both

Cookies

The Company may use cookies and similar techniques (hereinafter: Cookies). With this (personal) data is collected, stored and/or shared via the User's browser to remember User's preferences and to recognize Users on a next visit. Cookies also enable the Company to collect information about the use of the services of the Company, to optimize them and to adapt them to the wishes of Users.

Most browsers are set to accept cookies by default. However User can reset the browser so that User does not

The Company uses so-called session cookies and session storage on the website. Session cookies are functional cookies, intended to make the website function properly. It is not necessary to ask the internet User for permission before using session cookies. These cookies contain a different temporary number each time the User visits the website. These functional cookies are deleted after closing the browser of User. By means of

Functional Cookies, the Company ensures that the website functions properly. In addition, the Company may use cookies for which we need User's consent. It is possible to set the User's browser in such a way that cookies are handled in a certain way. For example, it is possible not to accept

have consequences for the User options or experience of the website. If the User has any questions about cookies, please contact the Company. Marketing Cookies from the Company and third parties may be placed on the Company's website. The

marketing Cookies of the Company may also be placed on third party websites. The information from the

The Company then uses settings that ensure that only anonymized IP addresses are processed (of which the last byte has masked), the Company has not given Google permission to use the data for their own purposes and the Company does not use any other Google services in combination with the Google Analytics cookies. If the User wants to disable these cookies, he can do so by using the Google Analytics Opt-out Browser Add-on.
